At all times relevant to this Agreement, Booth Operator agrees to comply with any and all applicable federal, state, county and city laws, ordinances, rules and regulations (the "Laws"), and also any and all rules and regulations and policies adopted by Harvest Homecoming or its designated committee (the "Rules"), whether now existing or subsequently adopted.
3. This Agreement shall be subject to termination by Harvest Homecoming without notice or hearing upon any violation of the Laws and/or Rules by Booth Operator, or its agents, employees or other designees.

Booth Operator hereby indemnifies, defends, and holds harmless Harvest Homecoming, its officers, agents, contractors, and employees from any and all claims, demands, actions, causes of action, suit, or proceeding for loss of damage incurred, either in whole or in part, by the negligence or willful misconduct of Booth Operator, its officers, agents, contractors, and employees.

Booth Operator, for itself and its officers, agents, contractors, and employees, their respective successors, assigns, heirs and/or personal representatives, hereby releases Harvest Homecoming, its officers, agents, contractors, and employees from any and all liability for any claims, demands, actions, causes of action, suit or

proceeding for any loss or damage suffered by Booth Operator, its officers, agents, contractors, and employees, arising out of Booth Operator's participation in the Harvest Homecoming Festival. Booth Operator assumes the risk of all injuries resulting from participation in the Harvest Homecoming Festival and personal injuries to me and damage to and loss of my property, and any other indirect or consequential damages, resulting directly or indirectly, wholly or in part, from my participation in the Harvest Homecoming Festival and while traveling to and from the Harvest Homecoming Festival.
